STEP 1: PRE- LICENSING EDUCATION

Go to XCEL Testing Solutions-

<https://xceltestingsolutions.myabsorb.com/#/catalog>

Select- "Insurance English- Pre-Licensing Bundle Course

Then Select your course- California Insurance

Select: California Pre- Licensing Education- Life, Accident and Health Insurance

then Click on "Proceed to your cart".

For the Discount Code- enter Transpacific. Total will be \$30.95 then proceed to Check Out and follow instructions to enter your information and pay for the course.

You may now begin your 52- hour pre- licensing course

STEP 2: SCHEDULE AND TAKING THE EXAMINATION

When scheduling your exam, go to <https://candidate.psiexams.com/>

Register for an examination

Select an Organization- Government/ Licensing Agencies

Select Value- California then Department of Insurance

Select Life, Accident and Health Agent Examination (Life Agent) CA
PSI Site \$88 or CA CDI Site \$55

Complete billing information and Schedule your exam

****Once you pass, there is an authorized technician on site to do the fingerprint requirement impression by the CDI. At PSI's test centers, the total processing fee for the fingerprint impressions taken is \$68.95 which includes the FBI processing fee of \$17, DOJ processing fee of \$32, and the rolling fee charged at PSI's test centers of \$19.95. The \$68.95 fee is to be paid at the PSI test center.**



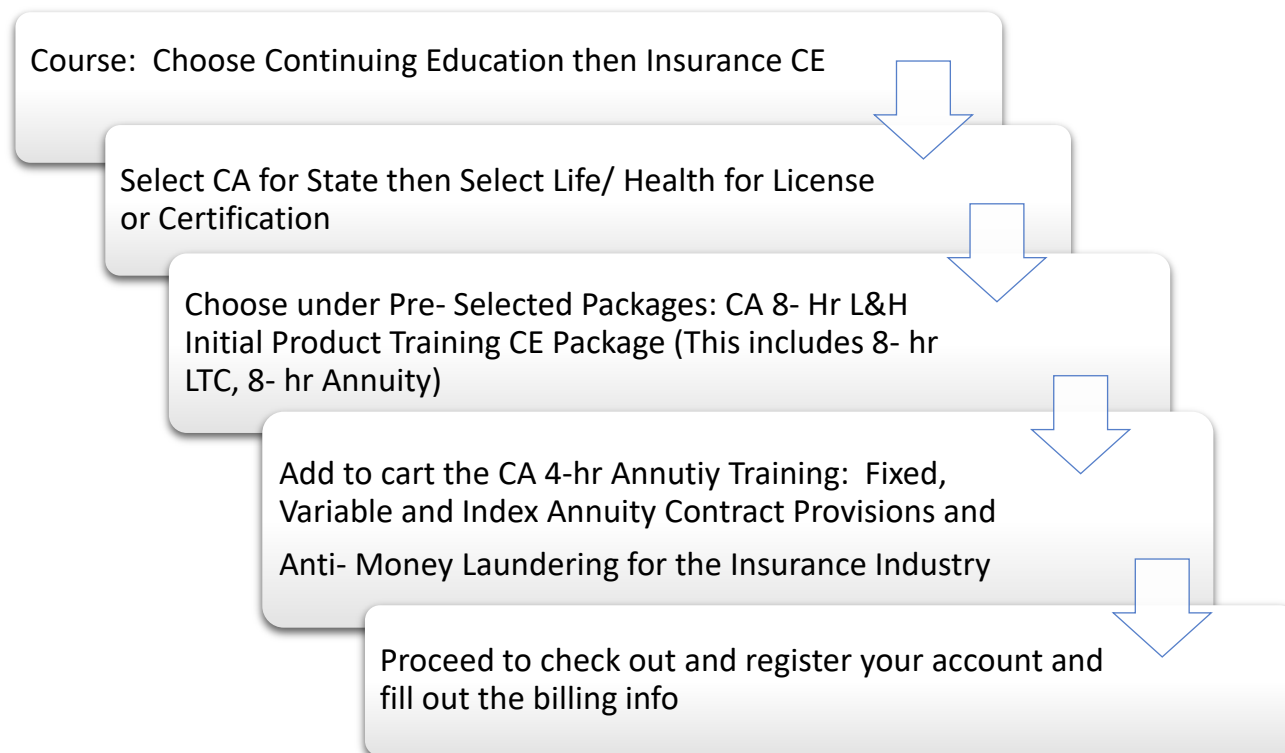
STEP 3: APPLYING LICENSE FOR THE STATE

- After passing the exam, you will need to go to www.insurance.ca.gov to apply for your state license.
- Once on the Home page, click on the Agents and Brokers tab and select Applying for a License.
- Choose Individual Resident License then Select Filling Online
- Click on the link for Sircon Online Services or the National Insurance Producer Registry. Follow the instructions in filling out the application and they will require to pay a processing fee. They will need some personal information (i.e. Social Security) to verify your identity. The Department of Insurance will give you updates on the processing via email.

STEP 4: CORPORATE APPOINTMENTS

Once you got your NPR Number and License Number, you will need to get appointed with the Companies we work with to be able to sell their products and get commissions. Most of the companies require Continuing Education Certification Units from online training classes for Anti- Money Laundering (AML), Long Term- Care (LTC), initial 8- hour Annuity and 4- hour Annuity.
